# Instructions for consigning shipments to Bharat Logistics :

# Shipping Instructions for Freight Forwarding :

Advance manifest filing requirement :

The freight forwarders/ liners are required to file the Customs manifest in advance before arrival of flight / vessel into India. Absence to file advance manifest or error in manifest filing causes huge penalties, amendment expenses and much delays in customs clearance.

We need to receive the prealert of final documents viz. Master, house Bl/Awb& cargo manifest copies atleast 5 days before vessel arrival into India and 1 day prior to flight arrival into India. Please intimate clearly if any amount need to be collected before release of consignment.

The packages need to be marked with Master and House Awb numbers to avoid penalties and additional expenses.

The packages containing wood (other than processed wood) need to be fumigated.

The Bill of Lading / Airwaybill need to mention the GST number of c'nee for shipments to India. Please obtain the same from c'nee and mention the same in the BL/Awb.

Original commercial invoice &packinglist are needed by customs for clearance in India in most cases. It is highly recommended that original documents be sent with airline pouch for air shipments.

We also recommend that the free days of demurrage be mentioned in the Master BL to avoid problems with c'nee/ liner at destination.
